O R D E R

As per the representation read as first paper above it has been requested to issue OBC Certificate and creamy Layer Certificate to those whose caste was mentioned in the School Certificate as "Chetty" alone without mentioning any sub caste name.

Shri.K.S.Copala Pillai, Thannuvila Puthen Veedu, Vadakkumkara West, Umayanalloor, Kollam filed O.P.No.13461/97 before the Hon'ble High Court with a prayer to treat the "Chett" Community and also its other sub divisions to which the petitioner belongs, as OBCs.

While allowing the O.P. on 29-10-98 the Hon'ble High Court directed the petitioners to make a detailed representation before the State of Kerala within a period of two months from the date of receipt of copy of the judgment.

Accordingly the representation read as third paper above has been preferred by the petitioner which has been received by Government on 15-3-99. Thereafter Government have sought and obtained extension of time upto 3-12-99 and a further extension of time for 3 months from 4-12-99 has also been sought to implement the directions of the High Court.

Government after having examined the matter in detail are pleased to order that in cases where the names of Groups are shown within brackets following the name of the main communities in the State OBC list only the groups

shown within brackets will be eligible for reservation in Public Services. Therefore, the community, "Chetty", having the sub castes names within brackets alone be ~~xx~~ treated as OBCs and therefore, the request of the petitioner is hereby rejected.
