ORDER

In the representation submitted to Kerala Legislative Assembly Sri. Kunnathody Panjan has pointed out that Palisa Perumkollan community is socially, educationally and economically backward and has requested Government to include them in the State List of OBC.

The Kerala State Commission for Backward Classes has examined the request contained in the representation in detail taking into account of the report of the KIRTADS and in the light of the criteria fixed for including a particular community in the state list of OBC. The Commission has examined in detail the evidences both written and oral as produced by the petitioner and also the report of the Director KIRTADS.

After detailed examination, Kerala State Commission for Backward Classes came to the conclusion that Palisa Perumkollan community have to be one of the sub classes of Viswakarma and advised Government that item No.30 of List III of schedule to Part I in KS&SSR, 1958 have to be amended including Palisa Perumkollan along with other sub classes of Viswakarma. The advice of the Commission shall ordinarily be binding upon the Government.

In the circumstances, Government are pleased to accept the advice tendered by the Kerala State Commission for Backward Classes.
