ORDER

In the representation submitted to the Kerala State Commission for Backward Classes, the President, Edanadan Chetty Welfare Society, Kartikulam, Mananthavady has stated that Edanadan Chetty community is socially, economically & educationally backward and they do not have adequate representation in Government services and hence he has requested to include Edanadan Chetty also with other sub castes of Chetties in the State List of OBCs.

The matter was referred to KIRTADS by the Kerala State Commission for Backward Classes. The KIRTADS has conducted a study on the social, economic & educational status of the community and has submitted the report to the Commission.

The Kerala State Commission for Backward Classes has examined the matter in the light of the report of KIRTADS and the criteria fixed for including a particular community in the State List of OBCs and came to the conclusion that Edanadan Chetty community satisfies the condition for including them in the State List of OBCs.

The Commission rendered their advice to Government that Edanadan Chetty is entitled to be included among other Chetties shown in Item No.13, Chetties in list III of Schedule to Part I in KS &SSR 1958 and the said item No 13 has to be amended including Edanadan

Chetty in the said item No.13. The advice of the Commission shall ordinarily be binding upon the Government.

In the circumstances Government are pleased to accept the advice tendered by the Kerala State Commission for Backward Classes recommending the inclusion of Edanadan Chetty along with other Sub Castes (components) specified within brackets of item No.13 Chetties contained in the List III of Schedule to Part I in KS&SSR 1958 and orders issued accordingly by amending item No. 13.
