O R D E R

In the Government Order read, orders have been issued including the 'Marathi' community in Hosdurg and Kasaragod Taluks in the OEC list, making the members of the community eligible for all the educational benefits admissible to the Scheduled Tribes for the year 2003.

Peoples' representatives have requested Government to continue to allow the benefits till the Government of India issues orders on the recommendation made by the State Government to retain the 'Marati' community in the ST list. It has also been requested that the name of the community spelled wrongly as 'Marathi' in the Government Order read may be corrected as 'Marati'.

Having examined the matter in detail, Government order that the Marati community be included in the OEC list, making the members of the community eligible for all the educational benefits admissible to Scheduled Tribes, until the Government of India issues orders on the recommendation made by the State Government to retain the community in the Scheduled Tribe list.

Government also order that the name of the community spelled 'Marathi' in the Government Order read is corrected as 'Marati'.

The Government Order read stands modified only to this extent.


